- **Enter in Person at Each Home during the Educational Home Tour:** When visiting your first home make sure you pick up a tour pass / check in card. This card will be yours for the entire tour until your last home. Fill out the top of the card with your name, email, and how you heard about the tour. At each home you visit, the host will punch your check in card with our special punch marking which homes you have visited. **Make sure to turn your tour pass / check in card at the last home you visit to be entered to win.**

All of the Drawing information will be posted at the Drawing Site at: <http://castlehometour.com/2017-contest/> throughout the Drawing. You may enter only once during the Entry Period. Limit of one entry per person and per household, regardless of method of entry. Duplicate entries from the same e-mail address/household will be automatically eliminated. Where a dispute arises about who submitted an online entry, the entry will be deemed submitted by the holder of the e-mail account.

The official winners (the "Prize Winners") will be randomly drawn in separate drawings. All drawings will be held on October 10, 2017 at approximately 2:00 pm.
